Our process

Organisational assessment: We assess the organisational arrangements, including organograms, governance structures, schemes of delegation, (roles and responsibilities) and functional strategies.

Benchmarking: we gather and benchmark data on the people (FTEs) and end-to-end costs involved in delivering back-office functions at both central and school levels.

Staff satisfaction: we survey education and operational staff, as well as Trustees and Governors, to gather their perspectives on operational strengths, weaknesses, and opportunities for improvement.

Data collection: we gather a high-level view of your IT systems, including Finance, MIS, Assessment, HR, Health and Safety, and Asset Management.

Our work

What happened next

Following the appointment of a new CEO, our report was adopted as the implementation plan. The trust continues to assess its progress against the findings and recommendations.


